108/2024 Safety in the Parish

Verges have started to be cut but care required particularly around large farm machinery. Poor driving / speeding reported on the road past Ollerton Business Park.

109/2024 Highways and footpaths

a. Update on Crow Lane Weight Limit

Signage now all in place.

PC are contacting businesses who exceed the limit, however, they need to have a clear explanation as to exactly where the weight restriction begins and ends.

Cllr. Gittins to contact SC again for clarification on "Except for Access" wording on sign at St Michaels Way.

Some reports from parishioners that HGV traffic has reduced.

b. Eaton Road (village part) safety improvements

VAS/SID (speed indicator devices) on the Eaton Road. Still no response from PCSO Tara Carruthers regarding a survey of Eaton and Howle Road (at Leafields).

Action: Chair will chase this up.

c. A41 working group – updates on new cross county group.

No further update.

d. Footpaths – to consider any queries which may impact on the parish.

Market Drayton Ramblers have contacted PC concerning issues with parish footpaths, blockages and broken stiles etc. Cllr. Letts to follow the queries up. This will be followed up at next CEPC meeting with Cllr. Letts.

e. Streetlights - Lamp replacements. Dark skies initiative.

Broken streetlight at Leafields has been reported and new light ordered. Replacement quoted at £290. Not replaced as yet.

Invoice received for payment of replacement bulb at St Michaels Way.

Dark Skies. Action: Chair to further investigate Dark Skies Initiative with SC.

110/2024 Parish Matters

a. Land Transfer - update on land registration.

b. FTTP/Gigabit roll out in the parish.

Chair has received a schedule from Freedom Fibre for installation of poles and Chair requested the plan with no response. Action: Chair to chase.

c. Trees – Tree Preservation, planting, and maintenance.

All three oaks planted for the Queen's Green Canopy are doing well. A fourth has now been planted and this is also doing well. Chair to check positioning of 3 x plaques.

Large Tree on the Village Green requires tidying up, branches are overhanging. This will be done during the Village Tidy Up 29th June.

d. Proposed Village Tidy Up 29th June 2024.

Date confirmed. Chair to produce list of actions required in advance. Date to be advertised to community in newsletter and on website. PC discussed the nomination for the Best Kept Village Competition and decided to enter.

e. Dog Fouling in the Parish

Cllr. Gittins has provided contact details for the Dog Warden. Chair to put out dog waste bags at existing bins to encourage correct disposal. Chair will liaise regarding new dog waste bin. Preferred location is around Bembow's area.

f. Blocked Footpaths

PC discussed parking in the village which is blocking footpaths. The issue was brought up at the APM. PC are unable to enforce legally. Reminders added to newsletter.

g. Marcus Mackay Recognition

Chair has discussed with Chrisine who was supportive of wildflower planting in the Autumn along the Howle Road which Marcus had started.

Plaque to be placed either on the playground or at the new oak tree recently planted. Action: Clerk to order plaque.
